FRAZIER STATED THAT SHE HAS A DRINKING PROBLEM, AND THAT WHEN SHE DRINKS TOO MUCH SHE GETS MEAN, AND OFTEN WILL MAKE UP STORIES.

SGT. EBLE WAS JOINED BY DETECTIVE JOHNSON OF THE HARRIS COUNTY SHERIFF'S DEPT. WHO JOINED IN THE INTERVIEW. SGT. EBLE INTRODUCED JOHNSON TO FRAZIER, AND SGTS. EBLE AND MEHL LEFT THE ROOM TO RUN A CHECK ON FRAZIER. SGTS. LEARNED THAT FRAZIER WAS LISTED IN TWO INCIDENT REPORTS. FRAZIER WAS , AND AFTER REVIEWING THE REPORT IT WAS LEARNED

FRAZIER WAS LISTED AS A COMPLAINANT IN INCIDENT #11487189, WHICH WAS AN INVESTIGATIVE HOMICIDE REPORT FRAZIER CLAIMED IN THAT REPORT THAT SHE HAD BEEN SHOT IN THE ARM BY A SONNEY WILLIAMS W/F 39 WHO SHE LISTED AS THE OWNER OF PAT'S LOUNGE. THE OFFICER NOTED THAT SHE HAD A SMALL HOLE, ON HER LEFT ARM, BUT SHE REFUSED ANY TYPE OF TREATMENT. FRAZIER LISTED A GEORGE PATCHIN AS A WITNESS TO THE OFFENSE, AND GAVE THE OFFICER AN ADDRESS OF 8751 KEMPWOOD FOR PATCHIN. SGT. MEHL RAN A CHECK ON PATCHIN WHO CAME UP CLEAR, AND SHOWED AN ADDRESS OF 8751 KEMPRIDGE ON HIS TX. DRIVERS LICENSE. THE OFFICER NOTED IN HIS REPORT THAT PATCHIN HAD NOT BEEN AT THE SCENE UPON HIS ARRIVAL.

SGT. EBLE THEN CONTACTED PAT'S LOUNGE AT 462-9109, AND ASKED TO SPEAK TO SONNEY WILLIAMS. A BILL WADE ANSWERED THE PHONE AND STATED THAT HE WAS THE OWNER OF PAT'S, AND THAT HIS WIFE'S NAME WAS SONNEY WADE, AND NOT WILLIAMS. SGT. EBLE ASKED WADE IF HE WAS FAMILIAR WITH FRAZIER, AND HE STATED THAT SHE DRANK HEAVILY AND HAD NOT BEEN TO HIS BAR LATELY. SGT. EBLE ASKED WADE IF HIS WIFE HAD SHOT FRAZIER OVER AN ARGUMENT, AND WADE STATED THAT HAD NEVER HAPPENED, AND THAT HE DID NOT KNOW WHAT I WAS REFERING TO. SGT. EBLE THEN ASKED WADE IF HE KNEW THE LOCATION OF DON'S BAR, AND HE STATED IT WAS ON HEMPSTEAD HWY. BY TIDWELL.

SGT. EBLE THEN WENT INTO THE INTERVIEW ROOM, AND ASKED FRAZIER IF THE WOUND ON HER ARM WAS THE RESULT OF HER BEING SHOT ON FEBRUARY 07, 1989, AND SHE STATED THAT IT WAS, BUT THAT THE DATE WAS FEBRUARY 08, 1989. SGT. EBLE THEN ASKED FRAZIER WHO HAD SHOT HER, AND SHE STATED HER BOYFRIEND GEORGE PATCHIN. SGT. EBLE ASKED FRAZIER WHY SHE HAD STATED IN THE REPORT THAT IT WAS SONNEY WILLIAMS, AND SHE STATED THAT SHE WAS TRYING TO COVER UP FOR GEORGE. FRAZIER THEN STATED THAT SHE WAS NOT EVEN SURE THAT SHE WAS SHOT. FRAZIER STATED THAT SHE WAS IN A FIGHT WITH GEORGE, AND A GUN WENT OFF, BUT SHE DID NOT KNOW IF IT HIT HER, OR IF SHE HIT HER ARM ON THE STOVE. SGTS. EBLE AND MEHL THEN LEFT THE HOMICIDE OFFICE IN AN ATTEMPT TO LOCATE

DON'S LOUNGE, AND DETECTIVE JOHNSON CONTINUED THE INTERVIEW OF FRAZIER.

SGTS. ARRIVED AT DON'S LOUNGE AT APPROXIMATELY 7:00 P.M., AND NOTED THAT THE ADDRESS WAS 14,104 HEMPSTEAD HIGHWAY, APPROXIMATELY THREE BLOCKS FROM THE LOCATION WHERE FRAZIER WAS ARRESTED. SGT. EBLE ASKED TO SPEAK TO "KERSA", TED AC MUE DADMENDER SCT. ERLE WAS INTRODUCED

TO "KERSA" WHO STATED HIS ACTUAL NAME WAS KENNETH SOUZA, D.O.B.-03-09-44, W-462-9155, HOME ADDRESS 7830 LAWNWOOD LN. H-893-1418, AND THAT HE WAS THE MANAGER OF THE BAR. AS SGT. EBLE SPOKE TO SOUZA, SGT. MEHL SPOKE WITH EDITH CUNNINGHAM W/F THE BARTENDER. SGT. EBLE ASKED SOUZA IF HE WAS FAMILIAR WITH JUDY FRAZIER, AND SHOWED HIM A POLAROID PICTURE OF FRAZIER TAKEN AT THE HOMICIDE OFFICE. SOUZA STATED THAT HE KNEW HER, AND THAT SHE FREQUENTED THE BAR. SGT. EBLE ASKED WHEN SHE WAS LAST AT THE BAR, AND HE STATED YESTERDAY. SOUZA STATED THAT SHE HAD COME WITH HER ROOMATE SHIRLEY, AND THAT HE WAS NOT SURE WHAT TIME THEY CAME, BUT HE THINKS IT WAS AROUND 3:00 P.M. SOUZA STATED THAT SHIRLEY LEFT, AND THAT FRAZIER STAYED. SOUZA STATED THAT HE TOLD FRAZIER HE WOULD GIVE HER A RIDE HOME IF SHE NEEDED IT, AND THAT HE DOES NOT REMEMBER EXACTLY WHEN SHE LEFT. SOUZA STATED THAT IT WAS WELL AFTER DARK WHEN FRAZIER LEFT, BUT HE COULD NOT BE SURE ON THE TIME. SGT. EBLE ASKED HIM FOR AN APPROXIMATE TIME, AND HE STATED THAT HE DID NOT KNOW, BUT HE WAS GUESSING SHE LEFT AROUND 8:00 P.M. TO 9:00 P.M. SOUZA STATED THAT HE REMEMBERS HER ASKING SOMEONE FOR A RIDE, BUT HE COULD NOT REMEMBER WHO. SPOKE TO A DAWN RODRIGUEZ W/F 22, WHO STATED THAT SHE HAD BEEN WORKING LAST NIGHT. SGTS. SHOWED RODRIGUEZ AND SEVERAL OTHER EMPLOYEES, WHO HAD BEEN WORKING THE PREVIOUS NIGHT, THE PICTURE OF FRAZIER, AND THE DEAD GIRL. NO ONE RECOGNIZED EITHER PICTURE, AND THEY STATED THAT THERE HAD BEEN NO FIGHT AT THE BURGER KING ON SATURDAY NIGHT.

SGTS. THEN PROCEEDED TO 11,718 C-12, THE ADDRESS THAT FRAZIER GAVE AS HER AND BOLGER'S RESIDENCE. SGTS. ARRIVED AT APPROX. 7:55 P.M., AND SPOKE TO SHIRLEY KATHERINE BOLGER W/F D.O.B. 06-20-24. AS SGTS. PULLED UP TO THE MOBILI HOME SGTS. OBSERVED BOLGER'S VEHICLE PARKED AT HER HOME, AND NOTED THAT THE SGTS. INTRODUCED THEIRSELVES TO BOLGER, AND EXPLAINED THAT THEY WERE CONDUCTING A HOMICIDE INVESTIGATION. BOLGER WAS ASKED WHAT SHE AND FRAZIER HAD DONE ON SATURDAY AND SHE RELATED THE FOLLOWING; BOLGER STATED THAT SHE AND FRAZIER HAD GONE TO DON'S LOUNGE AT APPROX. IT SHOULD BE NOTED THAT THIS QUESTION WAS ALSO ASKED OF SOUZA, WHO HAD ALSO STATED THAT GEORGE HAD NOT BEEN AT THE BAR ON SATURDAY. SGTS. ASKED BOLGER IF GEORGE HAD EVER HIT FRAZIER SO BAD AS

SGTS. THEN LEFT BOLGER'S RESIDENCE AND RETURNED TO THE HOMICIDE OFFICE. SGT. EBLE ADVISED FRAZIER THAT NO ONE AT THE BAR, OR AT BURGER KING HAD WITNESSED HER BEING IN A FIGHT, AND FRAZIER STATED THAT THE PEOPLE AT DON'S BAR WERE LYING. FRAZIER THEN STATED THAT THE GIRL SHE HAD THE FIGHT WITH WAS TRACY. SGT. EBLE THEN CALLED DON'S BAR AT 462-9155, AND SPOKE TO EDITH CUNNINGHAM. SGT. EBLE ASKED CUNNINGHAM IF SHE KNEW A GIRL NAMED TRACY, AND SHE STATED THAT SHE DID. SGT. EBLE THEN ASKED IF TRACY HAD BEEN IN THE BAR ON THE PREVIOUS EVENING AND SHE STATED THAT SHE WAS. SGT. EBLE THEN ADVISED CUNNINGHAM THAT FRAZIER HAD STATED SHE HAD BEEN IN A FIGHT WITH TRACY, AND CUNNINGHAM STATED THAT THEY HAD BEEN IN A BAD ARGUMENT, AND THAT SHE HAD TOLD THEM TO TAKE IT OUTSIDE. CUNNINGHAM STATED THAT SHE DID NOT KNOW WHAT HAPPENED AFTER THEY LEFT, BUT IF THEY FOUGHT IT WAS OUTSIDE THE BAR, AND NOT IN. SGT. EBLE THEN ASKED CUNNINGHAM HOW TO GET A HOLD OF TRACY, AND SHE STATED THAT SHE DID NOT KNOW. CUNNINGHAM STATED THAT TRACY WAS A REGULAR CUSTOMER, AND SHE AGREED TO GIVE TRACY SGT. EBLE'S BUSINESS CARD SO SHE COULD CONTACT THE HOMICIDE OFFICE.

SGT. W.I. STEPHENS LEARNED THAT THE DEAD GIRL HAD BEEN IDENTIFIED BY THE I.D. DIVISION, WHICH HAD OBTAINED THE IDENTITY FROM THE COMPLAINANT'S FINGERPRINTS. THE COMPLAINANT WAS IDENTIFIED AS SHANTE DWAN COLLINS W/F 20. SGTS. EBLE AND STEPHENS THEN PROCEEDED TO 6301 ALFONO #36 TO INTERVIEW THE COMPLAINANT'S FATHER, AND STEP-MOTHER, KITTY SMITH, AND DWAYNE COLLINS, D.O.B.07-27-46. THE INTERVIEW WAS CONDUCTED IN THE LIVINGROOM.

SMITH STATED THAT THE COMPL JUST GOT OUT OF PRISON ON FEBRUARY 2ND. SHE ADDED THAT THE COMPL HAS BEEN A PROBLEM ALL OF HER LIFE AND WAS LIVING WITH THEM IN THE APARTMENT FOR A SHORT TIME. SMITH ALSO SAID THAT THE COMPL HAS BEEN A PROSTITUTE FOR MANY YEARS AND HAS BEEN TRICKING OUT OF THE "NORTHLINE MOTOR LODGE" ON AIRLINE. SMITH STATED THE COMPL WOULD ONLY DATE MEXICAN MEN AND HAS BEEN THAT WAY MOST OF HER LIFE. SMITH TOLD US THAT SHE LAST SAW THE COMPL ON WEDNESDAY NIGHT OF LAST WEEK. SHE SAID THE COMPL CAME BY THE APARTMENT AND APOLOGIZED FOR BEING A PROSTITUTE. SMITH ALSO STATED THAT THE COMPL WAS ACCOMPANIED BY A BLOND FEMALE. SMITH DID NOT KNOW THE NAME OF THIS FEMALE AND SAID SHE WAS ABOUT THE SAME SIZE AS THE COMPL AND MAYBE A LITTLE YOUNGER.

WE ASKED SMITH IF SHE KNEW WHO THE COMPL HAS BEEN RECENTLY ASSOCIATING WITH. SHE REPLIED THAT SHE DID NOT KINOW ANY ADDITIONAL INFORMATION AND THAT THE BEST BET WOULD BE TO CHECK AT THE MOTEL. SMITH DID SAY THAT THE COMPL SOME TROUBLE WITH A COLOMBIAN NAMED "PABLO" IN THE PAST. SHE ADDED THAT THE COMPL STOLE SOME ARTICLES FROM PABLO AND PABLO IS A DRUG DEALER.
