While the Suspect was being transported to the Westside Command Station to be booked for Public Intoxication she advised the arresting officer that she had witnessed the shooting death of a man and that the blood that was on

Detective Johnson told this detective that he was notified by H.P.D. that they had a person who claimed to have witnessed a homicide in the area near where the body of the Complainant was found. Johnson said he went to H.P.D. where he interviewed the suspect and took a written statement from her. Johnson stated the white jacket worn by the suspect was covered in blood as well as her purse. Johnson also stated that the suspect in her statement had admitted to knowing the Complainant and had been with the Complainant at teh time of the death. The suspect

does not remember where she met hte complainant. Frazier told this detective that she last saw the complainant just before she (Frazier) was arrested. Frazier stated that a M/M and the complainant had picked her up and had taken her to some sort of building, she can't to have sex with her and the M/M. Frazier said she did not have sex with either of the two. Frazier also said that teh complainant was nude, but that she can't remember if the M/M was and that he left and returned a few minutes later with the plastic barrel and he and Frazier let out of the car and arrested very soon afterwards.

Frazier denied knowing who the M/M was that did the shooting.)

Frazier also told this detective that at teh time she was very drunk and may have done the shooting herself, but didn't remember having done so.

Frazier agreed to take a polygraph test to determine the truth of what she was telling of her knowlege of the incident.

While interviewing Judy Ann Frazier this detective observed that she had several bruises on both arms and on the exposed portion of her chest above the neckline of her shirt.

Ernie Hulsey was called to conduct a polygraph examination of Judy Ann Frazier and arrived at the Homicide Office at 11:00 hours. The following questions were asked:

- Q: Are you delibertly with holding any information concerning your knowledge of this girl's death?
   A: No.
- 2) Q: Do you know who shot the girl in question? A: No.
- Q: Did you shoot the girl in question?
   A: No.
- 4) Q: Did you see the girl at the time she was shot?
- 5) Q: Do you remember helping to put the girl in the red can? A: No.
- 6) Q: Prior to this girl's death do you remember knowing or being with her in any way?
- 7) Q: Do you remember how you got the majority of the bruises on your body? A: No.

Upon the completion of the polygraph examination Hulsey advised this detective and Det. Johnson that the suspect had been untruthful on all of the questions asked. Hulsey stated he considered the suspect to be untruthful on the examination.

This detective again attempted to question the suspect. The suspect at that time told this detective that she was very intoxicated at the time of the death of the complainant and does not remember if she shot the complainant or if some-one else did it. She again told this det. that she does not know the M/M that was also present. At that time, 13:17 hours, the suspect

advised this detective that she did not want to say anything else until she had an attorney. This detective then concluded the interview.

This detective then took the suspect, Judy Ann Frazier, to the I.D. Div., where this detective requested Deputy S. Grounds, a female I.D.& Evidence Tech., to photograph the wounds adn bruises on the body of the suspect.

This detective then placed the suspect in a holding cell away from prisoners who have been charged with a criminal-offense.

This detective then examined the thin, white, nylon windbreaker that the suspect was wearing at the time of her arrest at 20:32 hours on 021889. The windbreaker had what appeared to be blood stains on both sleeves and on the back. The stains did not appear to be splattered as if she were standing near the complainant at the time of the shooting, but to have been made blood flowing from the wound of the complainant onto the jacket of the suspect as the suspect was moving the complainant. This view was also held by Cpl. P. Schroedter, I.D. Div., and Det. M. Cox, Homicide Div., who had just completed training in Blood Splatter Interputation. This detective took two color polariod photos of the windbreaker.

About two weeks ago I met a female that I know when I see her, I can't recall her name, I met her in bar off hemspstead Highway. This is the same female in the pictures show to me by Detective Johnson. We became friends and would just talk and drink together. She had asked me if I turned tricks and I said no, she told me she picked up extra money by turning tricks. I think I have seen her in a bar maybe two times and each time we got together and talked. On Saturday, I think it was February 18, 1989 early in the day Shelley and me had gone to Don's Lounge on Hempstead Hwy. around 12:00pm or 1:00pm. Shelley left long before dark maybe around 3:00pm and I stayed in the bar drinking beer, whiskey, and whatever. I got a real cockey attitude had one or to blows, Slaps or hits, outside the bar which was around 6:00pm. After the fight I walked back in the bar finished my drink and was about to leave when the bar owner asked if I wanted a ride and I told him no I'll just walk. I left out of the bar and started back towards the Burgerking on Mempstead. I was about eight (8) building down from the club when I got into a vehicle with the dead girl and a man, he was a mexican male, overweight, he had a medium complexion, he was about 5'8", I can't remember if he was clean shaven or not. When they first pulled up, the dead girl, started talking to me. The mexican male was driving and she was by the passenger car door. She asked me if I wanted to ride and go party. I was drunk and said what the hell and got into the vehicle. She slid over next to the mexican male and I sat next to the passenger door. We rode around and drank beer and parked at some business for awhile and smoked a joint. The business is called under ground steak house on Hempstead right Don's. We parked on the little street next to the building. We started talking about sex, they started kissing and feeling of each other and I asked them why don't they bring me home. She asked me then if I had ever been with a woman and I said I don't remenber ever being with a woman. She and the mexican both said don't knock it till you try it. She started playing with my boobs and he started the car up and started driving around some more. He then drove to a house in a wooded area, I really don't know where it was. We all got out of the vehicle and went into the house. Once in the house we smoked another joint. I am not she if the house we went into was a cabin, a house, or a mobil home. When we smoked the joint we were in the living room. They then starte smoking crack and I don't think I tryed it. They started talking about sex again. She started playing with my boobs again on the outside of my shirt. He came up to us and started feeling me and her off, I decided that if I didn't go along with them I would never get home. He then left the bedroom and was only gone about two or three minutes. When he came back into the room he had a red plastic can the they put beer keggs in. He made me pick her up with him. I picked her up by her feet and he by her shoulders. We then put her into the can. She had no clothes on at this time. Once we put her in the can, we carried her out to a vehicle and put her in it. Just before we got out of the house we put some trash on top of her. I can't remember what was said in the house before we carried her out. We got into the vehicle and he was driving. We drove around for awhile and I can't remember if I was with him when he got rid of the body and I don't remember how I got back on Hempstead or how I got away form him. The next think I remember is a cop picking me up. I remember nothing else.

He told this detective that he broke off the relationship about two weeks ago. Patchin blamed the breakup on the use of Cocaine by Frazier. Patchin told this detective that she had just recently taken up the use of cocaine and used it by injection. He claimed that she had gotten an abcess in her left arm in the wrist area through injecting cocaine in the arm and that she had missed the vein resulting in teh abcess. Patchin stated that Frazier had told everybody the wound on the arm was from him shooting her, but in truth the wound was from the abcess.

Patchin told this detective that the last time he saw Frazier was on Saturday evening, around 20:00 hours at Don's Lounge on Hempstead Rd. HISTORY: This 20 year old Caucasian female was found dead in a garbage can with a gunshot wound to the head at 1:00 p.m., on February 19, 1989, at 10,900 Cedarview, Harris County, Texas.

AUTOPSY: The autopsy was performed in the Joseph A. Jachimczyk Forensic Center of Harris County by Assistant Medical Examiner Robert A. Jordan, M.D., at the request of Chief Medical Examiner Joseph A. Jachimczyk, M.D., J.D., beginning at 12:10 p.m., on February 20, 1989.

EXTERNAL APPEARANCE: The body was that of a well developed, well nourished, adult Caucasian female, measuring 64 inches in length and weighing 127 pounds. The physical age appeared older than the chronologic age of 20 years. There was fixed rigor of the extremities and mandible. The scalp was covered with red-brown hair which measured up to 18 inches in length at the crown. There was a close range-type gunshot wound of entrance above the right ear. The sclerae were white, pupils round, regular and equal, the irides hazel. Quantities of eye shadow were present on the upper and lower eyelids. The nose was intact. The ears were symmetrical. teeth in good repair were present. A 1/2 inch scar was present on The neck was symmetrical. The neck veins were not the chin. The anteroposterior diameter of the thorax was within distended. The intercostal spaces were not prominent. normal limits. breasts were soft and protuberant. The abdomen was soft and flat. The hair distribution was female. The perineum There were no scars. was otherwise unremarkable. The lower extremities were equal in length and volume. There was no pitting edema. Multiple circular scars were present on both shins. The upper extremities were equal in length and volume. The fingers were rigid in flexion. There were multiple contusions on the dorsal surface of both hands. There were old needle tracks in both antecubital fossae and on the arms. were multiple tattoos on both arms. The back was intact. There was posterior unfixed lividity. The cerebrospinal fluid was grossly bloody.

INTERNAL EXAMINATION: Section: The body was opened with the usual Y-shaped incision and the superficial abdominal fat measured 3/4 inch in thickness at the umbilicus. There was no free fluid within the abdominal cavity and the serosal surfaces were smooth and glistening. The appendix was present at the tip of the cecum. The diaphragm was intact. Both heart and lungs were in their normal anatomic location. There was no free fluid within either

hemithorax. The pericardial sac, rib cage and sternum were intact.

HEART: The heart weighed 260 grams and was covered with a thin layer of yellow fat. The myocardium was uniformly red-brown and soft. The ventricular chambers were empty. The valvular measurements were within normal limits. The coronary arteries were dissected throughout their length and were normal. The thoracic and abdominal aorta were unremarkable.

LUNGS: Both lungs together weighed 850 grams. The pleural surfaces were pink-red. The interlobar fissures were well demarcated. On section, the parenchyma was well aerated. No free fluid exuded from the cut surfaces. The mucosa of the trachea and major bronchi was covered with a thin layer of clear mucoid material and the mucosa was intact. The pulmonary vessels were unremarkable.

LIVER: The liver weighed 1560 grams and was red-brown. The capsule was smooth. On section, the parenchyma was of similar coloration and the lobular markings were not distinct. The gallbladder contained 20 milliliters of green viscid bile. There were no calculi.

Pancreas and Adrenals: The pancreas and adrenals were grossly normal.

SPLEEN: The spleen weighed 140 grams and was red-brown. The capsule was smooth. On section, the pulp was soft and the follicles were distinct.

GENITOURINARY TRACT: Both kidneys were similar in size and shape and weighed totally 260 grams. Both organs were covered by a thin partially transparent capsule which stripped with ease, revealing smooth red-brown parenchymal surfaces. On section, there was good corticomedullary differentiation and the pelves were not dilated. The ureters were dissected throughout their length into the urinary bladder and were found to be patent and of normal caliber. The urinary bladder was empty. The uterus, fallopian tubes and ovaries were intact and unremarkable. There was no trauma to the vagina or cervix.

GASTROINTESTINAL TRACT: The esophageal mucosa was gray and intact. The stomach contained approximately 30 milliliters of gray granular fluid. The rugal pattern was well preserved. There was no ulceration or hemorrhage. The remainder of the tubular gastrointestinal tract, including the duodenum, jejunum, ileum and large bowel, were unremarkable.

NECK: The chest flap was reflected cephalad and the neck organs removed. The tongue, hyoid bone, thyroid cartilage and vocal cords were intact. The mucosa was intact.

HEAD: The scalp was incised with the usual ear to ear incision, reflected and the calvarium removed. There was diffuse subgaleal hemorrhage in the right parietal and left parietal areas. The surfaces of the cerebrum and cerebellum were covered with a thin layer of fluid blood. The brain was removed and weighed 1400 grams. The dura was stripped and there was a gunshot entrance wound in the right parietal area with the edges beveled inward. Repeated coronal sections through the cerebrum and cerebellum revealed a gunshot track through the right parietal area, across the midline into the left parietal area. The surrounding cortex was hemorrhagic and friable. Bone fragments were present along the wound track. There were no contusions. The vessels at the base were unremarkable.


DESCRIPTION OF CLOTHING: No clothing was present on the body.

DESCRIPTION OF INJURY: (Path of the missile) A bullet entered the right side of the head, at a point 2 inches above the nasion and 5 inches to the right of the anterior midline traveling from right to left in a straight line into the skull and through the brain to lodge against the left skull. The entrance wound was round, measured 1/4 inch in width and was surrounded by a concentric abrasion collar which measured up to 1/16 inch in width. Stippling was noted. There were no powder deposits within the wound. A full copper jacketed .25 caliber bullet was recovered from the left temporoparietal cortex, initialed with the letter "I" and preserved.





Battaglia further stated that later Officer Salazar stated that they were going to take suspect # 1 away from the house as if to take him to jail and suspect #1 would be released where upon he would return to the house on Cedar Hill and attempt to obtain more information on the homicide and Shirley or any other individuals possibly involutely Sgt. stated that this Detective could reach Officer Salazar at 222-0133, HPD"S Auto theft Division. Sgt. Battaglia stated that he and Deputy Youngblood left the house with HPD still there to complete their investigation.

At approximately 12:30am on March 29, 1989 Telephone contact was made by this Detect with Officer Salazar. Officer Salazar was briefed on the Sheriff's Department investigation and requested that he allow this Detective to interview his informant a soon as possible. Officer Salazar agreed and advised that he would recontact this Detective later this date and attempt to arrange a meeting. Officer Salazar advised that he would assist in anyway he could in this investigation.

After having spoke with Officer Salazar, a check on the Sheriff's Department's JIMS system found that the Shirley Sutherland identified on Cedar Hill was the individual wanted by this Detective.

A check of criminal warrants found Shirley Sutherland had an outstanding want on a DWI probation violation and it was confirmed by Detective in the warrants division. The warrant was under Shirley A Minske. Warrant #911427 out of county court 13.

A photograph of Shriley Sutherland was obtained from ID and is attached to this case file.

A check of the JIMS system found SPN numbers on Robert Manning (00331569) and Edward Elias Mark (00417602). Those records are attached to this case file

It was learned from Sgt. Battaglia that the address at 3422 Cedar Hill had no utilities and the occupants were using candles to light the house. A check with Houston Power and Light confirmed this.

HL&P records also showed that the residence belonged to a Jesse Ray James DOB10/18/88 telephone 677-2169. A TDL check found that the lic. was no longer in use. The SSN was not identifiable with any records on computer systems. A check of Mr. James on computers found no information available. A public service call was made to the telephone number and when Mr. James was asked for the party( a female) advised that she did not know any Mr. James. Sutherland, beat the complainant and threaten to kill her that same day. the suspect late advised Mrs. Cavazos that if she are any of her family ever said anything about her, suspect beating and threating to kill the complainant that all of them would be in big trouble. She further stated that she, Jesus Cavazos, Pedro Cavazos, and Yvonne all heard the suspect stated that she had killed the complainant because the complainant was sleeping with her husband. (SEE VOLUNTARY STATEMENT)

It was learned that the individual Yvonne was at the time the incident occurred with Shirle and the complainant was living 10124 SILVERCREST and after witnessing the beating and then being threaten by the suspect, she moved out of the house. Mrs. Cavazos advised that she had Yvonne new address and telephone number at home and would contact this Detective ASAP with that information.

A criminal history check of Jesus Cavazos, Pedro Cavazos, and Angie Cavazos found no criminal history on either of them.

Finger prints of the suspect, Shirley Sutherland, was compared with prints lifted form physical evidence obtained form the crime scence. Those prints did not match up. However, Dpeuty Rossi, with ID, stated that one print did come close, but there was not enough points for him to be positive.

Jesus Cavazos, Pedro Cavazos, Angie Cavazos, and Arnulfo Ramirez all stated that they knew the suspect by sight and by her first name. Pedro and Arnulfo stated that they have known the suspect for at least two (2) years. Jesus and Angie stated that they have known the suspect for at least 6 months. All were shown a photograph of Shirley A Sutherland, and all stated that that photograph was the Shirley they all knew and had given statements about. I don't know his name. I don't recall having ever seen Shirley and Shanta together before and on the last night I saw Shanta alive was the first time I knew that Shirley and Shanta knew each other. On Sunday, the day Shanta was killed, I had seen Shanta and Shirley at my house around mid-night Saturday night or it could have been in the ealy morn ing hours of that same Sunday that Shanta was killed. Shanta had come over to the house around 9:00pm or 10:00pm on Saturday before she was killed. I don't know how Shanta got to the house, but she was alone. Shirley came over around 10:30pm on that same Saturday. Jesu Pete (Pedro), Yvonne, and myself were the only ones at the house with Shirley and Shanta. When Shirley and Shanta first got to the house they did not argue, but sat around and talk with every body. Everybody, except me and Yvonne, sat around smoking Marajuana and doing crack. Shanta was shooting up in her arm. All of them was getting messed up. Sometime later, Pete went to take a shower, Jesus was on the couch with Shanta and then Shirley sat down on the couch next to Shanta. Yvonne and me were setting on the other couch. After Shirley sat down next to Shanta, she (Shirley) starting hitting Shanta with something. Wha I am not sure of. Shirley started hitting Shanta on her legs, arms, chest, and head with the object. Shirley was hitting Shanta real hard. Shanta just folded up and said nothing. Shirley started saying, "Bitch, I'm going to get you, I'm going to kill you". "Your not going to make it through the night". Shirley said, " if I don't get you here, I'm to get you some where else". Shirley was hitting Shanta hard while she was saying this. I then told Yvonne to tell Shirley to leave and Shirley did. Later after Shirley left, Pete came out of the bathroom and he, Jesus, and Shanta somked some more marajuana and a little late Shanta left. I don't know how Shanta left the house. The time now was sometime around 1:00 or 2:00am Sunday morning. When Shirley had left she was real angre and slammed the door when she left. Nothing else happen until Monday morning when Shanta's dad came to the hous to buy some dope. He started crying and told us that his daughter had been killed. When he told us his daughter's name is when I first learned that he was Shanta's dad. Shanta's dad was told what had happen early sunday morning between Shanta and Shirley. I don't thin he knew who Shirley was. He then left and Shirley came over around noon. I asked Shirley if she knew about Shanta being dead. Shirley then said, "who's that, who's that". I then said, "the girl you were beating up Saturday night". Shirley then looked at me real funny and then said, "old that Bitch" and then she started outside. She then came back into the house where me and Yvonne were. No one else was around. Shirley then look at us real hard and she said, "tell Jesus not to tell nobody about what had happen that night". Then left and then came back later around 2:00pm. Jesus was at the house at this time. Jesus asked her if she knew what happen and Shirley said, " what", and Jesus said, " Shant dead". at this time They were in the kitchen. Me and Yvonne where in the livingroom which is next to the kitchen. I then heard Shirley say, " It was time for me to that the trash out when it was suppose to be out". Shirley then got next to Jesus and said to him, " I killed the Bitch". Jesus asked her why and Shirley said, " because she was sleeping with my husband and I put the Bitch outside in a trash can where she belongs". Shirley then told Jesus it was only between her and him. She then started bragging about it to Jesus, saying, "Alright, I did it". Shirley then turned and looked into the livingroom and saw me and Yvonne and she then walked toward us and says, " both of you keep your mouth shut, or else everybody is going to get into trouble". Shirley then said with a real big look," in real big trouble, I mean it". Shirley then left. Later Shirley would come back to the house and brag about having killed Shanta. ON one day she had come to the house with her son and Shirley said on that day that someone else was sleeping with her husband again and she was going to have to kill another one again. None of us told the police about all of this because we were afraid of getting into trouble about the dope in the house and so decided not to get involved. Q.C.

I have known Shirley about a year. I know her as Shirley Sutherland. My relationship with Shirley is as a contact to score drugs (Cocaine). I either get the drugs from her or she takes me to the place to get them. Generally she takes me to the locations to score. Everybody I know related to drugs I have met through her

I have also met Shirley's husband, Ron. Shirley has been seperated from him for about two months. I met Ron on several times at the house where he stays now. Shirley told me that she and Ron seperated because Ron needed to get his life together and find out what he wanted

I met Shantee Collins on one occasion. That was one night about late January of this year. At the time I was over at the house where Shirley lives now and Shantee came in. On that occasion they seemed to get along good to me.

Several weeks ago, I don't remember exactly when, Shirley told me that Shantee had gotten killed. The way she talked it seemed that it was just a few days earlier, maybe three or four days. Shirley had to remind me who Shantee was because I had only seen Shantee the one time. I asked Shirley why Shantee got killed and Shirley told me that Shantee owed a lot of people money for drugs. Shirley told me that somebody had blown Shantee in two with a shotgun and throwen her in a trash dumpster. That is about all she told me about the killing on that night. Shirley was the one that brought the subject up

About two weeks ago Shirley and I were doing some "Coke" and Shirley Started talking about a girl named "C.C." that Ron was fucking around with. Shirley told me that it wasn't the first time that Ron had fucked around on her. She told me that she caught him fucking around with Shantee. I asked her who Shantee was and she told me that it was the girl she had told me about getting killed. Shirley told me on the night I had met Shantee, Shantee had brought over some "Coke" and that while she (Shirley) was in doing some "Coke" Ron was fucking Shantee on the livingroom floor. Then Shirley told me that she had gotten into an arguement with Shantee over at Joe's and that she was going to kill her there But Joe told them to get out of his house. Shirley told me that the very next day "That Bitch" got killed.

Shirley told me about the fight and that she was going to kill Shantee on several occasions. Today Shirley finally told me that she was the one that killed Shantee. This time she said "I haven't told anybody, but I think you know that I did it (killing Shantee) and I know I did it, but nobody else knows." She said "I would have killed her at Joe's, but I didn't want anybody around when I did it." Shantee said "The Bitch fucked me over in my own house. Splayed and she paid" Shantee also told me that anybody that fucks over her would get thing.

Shirley also told me on one occasion that she didn't like messy killings, that she liked clean shots, like with a cross bow. I also have seen her with some pistols. One was a .357 and the other was a .22 revolver. I did not actually see the .357, just the box, but I did see the .22 revolver.

Today Shirley told me that she had gotten her eviction notice and she told me taht she was planning to move to Tennessee. She even told me that I should go there with her and we could start a business. She told me that he had gotten some inherentence and had some insurance money coming in and we could start a bar in Tennessee
